TRSY!

The spearhead of the collective action of the union to regulate platform work.

TRSY! consists basically of a website provided by UGT (second largest union at national level) targeted to **platform** workers.

UGT logo does not appear anywhere on the website.

 Intentional in order to attract people generally reluctant of unions action.

TRSY! provides several **services**:

- MailBox for initial questions on (bogus) self-employed rights.
 - Maximum deadline of 24 hours to provide clear information.
 - Provision of labour legislation basic information.
- Legal and Collective Bargaining coverage of out-of-employment-relations.
- Ultimately, collective coordination of these hard-to-unionised workers.



User trends:

- More than 2000 queries attended before the impact of the pandemic.
- Contacts increased exponentially in 2020 with the outbreak of the Covid 19 pandemic (Dufresne and Leterme, 2021).

User profile:

- Platform workers (main target): <u>58%</u> of these queries.
- Surprisingly, 42% of the consultations came from workers in rural areas
 - This profile of workers has grown due to the so-called "empty Spain"
 - Generally, with difficulties to access union representatives.



Impact on affiliations:

- Low (+/- 57), but expecting results in long-term.
- Affiliation is not the main index internally to evaluate its impact.

Impact in other issues:

- Open channel to contact the union
- Tens of favourable legal sentences.
- National regulation establishing mandatory employment relation to delivery platform workers.



TRSY! has provided:

- 1. Union coverage to out-of-employment-relation workers
- 2. <u>Legal representation</u> in judicial claims.
- 3. Institutional regulation of delivery platform workers (Law 9/2021).
- 4. Firsts collective bargaining processes at company level (e.g., JustEat)
- 5. TRSY! functioning currently as the "digital section" of the union.
